 - (1) Hired dedicated police officers to patrol the area between 11am-4pm (overtime officers)

 - b. Dedicated police officers to patrol the area between 11 and 4.

- More enforcement from police for scooters on the sidewalks

- Discussion of Geofencing to help curb using scooters for crimes

Police Liaison – Mark Hauenstein Frank Hall New Community Liaison Officer (614-645-1416)

- Statistics include entire Short North
- August 19 through current day
 - 15 violent crimes aggravated assaults, individual robberies
 - Correlated to Sunday times Midnight 2am; 4 robberies (spike in Dennison and 2nd area); 2 robberies Russell & High
 - Burglaries 4 commercial and 3 residential highest rate on Sunday (late Sat/into early Sunday morning)
 - Car thefts 11 motor vehicle thefts vary in hours/days; 4 related to running vehicles
 - 20 break-ins for motor vehicles (Wed/Thurs were highest days)
- Discussion consideration of putting Columbus Police Graphic on Smart Kiosks w reminders about safety practices
 - Katherine will ask CPD to see who can maybe work with SNA to put graphics on there
 - SNA does have an allocation of ad budget for public services announcements

- Chet inquired about seeing a map of 311 service requests
 - Katherine believed you could see all open and closed 311 requests in your area
 - Will look into this and talk to 311

G. Neil Avenue Street Scape Project

- 1. At last meeting, Bobby had emailed city
- 2. First Correspondence with Reynaldo Stargell with the Traffic Management Division:
 - a. What we see right now is permitted utility work that is taking place along Neil Avenue. The utility companies are relocating utilities for the new signal installations.
 - b. The entire project is scheduled for completion by the end of summer 2022.
 - c. Tree Removals
 - (1) One Tree Removal Planned: SE corner of Neil and King.
 - (2) One Potential Tree Removal: SE corner of Neil and Fifth (if there is significant root damage. Apparently a proposed power meter will be close to the tree).
 - d. Cameras on Poles
 - (1) When first designed, cameras were going to be used at all intersections at all traffic light intersections in order to monitor traffic. An extra pole would have been installed on each traffic pole and contain a mounted

camera to monitor traffic. That means four extra arms and cameras in all four directions.

- (2) Because of our community push back, the City changed to radar style vehicular detection. The radar will attach to the main arm off of each traffic pole (meaning no need for an extra arm) and no video cameras.
- (3) Four intersections will have an extra arm installed, but only one arm will be installed, and it will have mounted cameras to monitor traffic. Those intersections are Buttles, 5th Avenue, King, and 9th Avenue.
- (4) The extra arms will attach to the signal poles at a height of 26ft and extend over the intersection to a height of 35 feet.
- e. <u>Pedestrian Push Buttons</u>:

Most of the poles call for a separate pole to be erected on the corner for the pedestrian push button. A few locations will have the push button located on the signal pole, itself.

f. Walk Sign

In order to get a "Walk" signal, Pedestrians will need to push the Pedestrian Push Button.

- g. They also provided us with a copy of the plans.
- 3. <u>Follow Up with Reynaldo Stargell August 31, 2021</u>
 - a. Plans appear to call for non-decorative poles, meaning the bases of the traffic poles would just be a square. I submitted an inquiry asking about having the poles which have the more decorative base.
 - b. Inquired about making the "Walk" sign appear whenever the lights change, as they do now. It allows for a more pedestrian feel.
 - c. Inquired about the relocation of ADA accessible ramps so that the new traffic poles do not block the view of the pedestrian.
 - d. Still waiting on these answers.

- ii. Katherine is going to help with those poles
- a. Chet asked about the tree replacement on NW side of 5th

 - Map for initial comment period is using 2010 data (was unable to get 2020 census data in time)
 - Encouraged people to review the map, see where civic association is, and provide comments
