A. Financial Report -- Jim Farmer

- 1. Tour profit just under \$10K
 - (1) Ticket Sales
 - (2) Sponsorships
- 2. ~15,000 Chase checking
- 3. ~15,000 Chase savings
- 4. ~51,000 in Money Market Fund
- 5. Jim proposed to shift the money over to Vanguard Fund over a period of time; \$3,000/month
- Motion to authorize Treasurer to move \$36,000 50/50 Vanguard Bond and Stock Market Index fund over 12 months *Motion:* Jack

Second: Marc

IV. Neighborhood

A. Short Term Rentals in the Short North – Kevin McCain

Started working on code and getting amendments Short term rentals managed by the Division of Licensing

- Rentals of room or entire home for 30 days or less
- Oversees permits
- Do need a permit for every short term rental
 - Info;www.columbus.gov/str
 - Website has the ordinance, FAQ, the application needed, background check information, website links to codes
- Questions shorttermrentals@columbus.gov
 - Report issues
 - Register complaints

Also please use 311

- last round of legislation is July created a special category for short term rentals
- New 311 will allow for people to look up number of complaints associated with a property

Maps?

- There is no online public facing map of short
- Division Licensing has internal map
- Airdna.co -3^{rd} party map
 - subscription based but can view for free
- Division of Licensing can fill requests for listing of properties with licenses/applications

Changes

- only owners and permanent residents are allowed to have short term rentals
- if renter need permission from owner
- owners can be an LLC or business but still need to submit 24/7 local contact
- Application needs 24/7 contact in central ohio (this is public record and can be requested)
- Recent of legislation strengthened enforcement system to give the City strength to apply penalties

Kevin can with any questions; email is the best way to reach him Searchable database not available at the current time

Would encourage Civic associations to do a public records request

3 strikes is usually enough to initiate an investigations (Division of Licensing has discretion here)

Chet asked about AC Humko status with Rob Dorans

- Not tabled but not moving fast
- Requested to keep SNCA in the loop
- B. <u>Neighborhood Crime/Violence/ Crime Prevention:</u>
 - 1. <u>Short North Crime Interdiction Pilot Program update</u>:
 - a. Thursdays through Sundays;
 - b. Between three and eight officers;
 - c. 200 incidents in which officers have intervened:
 - (1) 26% of incidents involved a vehicle;
 - (2) 13% of vehicle incidents were OVI-related;
 - Has highlighted an issue with OVI issues after dark
 - (3) Remainder of incidents were miscellaneous behavioral or noise violations, vendor violations, fights, robberies, and shots fired;
 - (4) Investigations of "shot-fired" cases, but in most cases, nothing found;
 - (5) 3 documented incidents have resulted in the prevention of gun violence.
 - d. SNA has funding through end of November.
 - e. They will share final report after program is completed.

2. Short North Violence and Injury Prevention Workgroup

- a. Violence has decreased in the Short North. Believe it is due to the following:
 - (1) Short North Crime Interdiction Pilot Program;
 - (2) Scooter changes;
 - (3) Opening of other entertainment venues;
 - (4) Increased police presence.
- b. Police recognize the safety concerns, and will deploy extra resources, as they are able, to the Short North through December.
- c. <u>Safety Budget</u>
 - (1) Hiring 300 personnel in firefighters and police officers;

- d. Re-Evaluation of Neighborhood Safety Strategies set in 2018 (due to pandemic and way the City provides services); determine what programs were successful and expand those programs;
- e. <u>City is looking at technology</u>:
 - (1) Cameras around City to enhance safety footprint;
 - (2) Looking at use of Shot Spotter;
 - (3) Real-time crime center;
 - (4) Work with the SNA and the block watch in order to determine best place for cameras;
 - (5) Any technology will have dedicated personnel to cover the technology.

Crime report in the last month (Officer Hall)

11 violent assaults (majority in Weiland Park Area)

12 robberies to individuals (peak Sun – Fri); Hours btwn 6-9pm and 2am

6 motor vehicle incidents

77 report auto theft

10 commercial burglaries and 7 residential throughout the month

Chet – Asked Katherine about crime graphics discussed in a previous meeting and she will follow up

3. <u>Nuisance/Abatements/Complaints with bars/restaurants</u>

- a. Jenny Frankart & Bobby Meeting with Heidy Carr (Assistant City Attorney, Zoning Initiative);
- b. Nuisance Abatements
- c. Nuisance abatements are when the City uses the existing zoning codes, or building codes, in order to increase public safety and quality of life in neighborhoods.
- d. In essence, the city would use the codes in order to attempt to shut down a business.
- e. Types of crimes considered: felony drug crimes, violent crimes, prostitution, liquor violations, overdoses.
- f. Cannot file based on the calls but encourage this information to be called in to allow for further investigation (covertly). Narcotics have to do covert operations.
- g. City files an ex parte restraining order, asking the judge to shut board up a building or shut down a business.
- h. Bar Sweep Through Short North:

No health or liquor code violations discovered.

i. <u>Checksmart Building</u>:

Checksmart has been sent a warning letter by CPD regarding the possible criminal activities occurring, so they are on notice. They were warned that if they do not take action and an incident takes place, the City may take legal action.

j. <u>Noise violations</u>:

- (1) Hard to file anything about noise unless multiple people willing to testify.
- (2) Not enough for just one household to testify.
- (3) Best to deal directly with the bar owners
- (4) <u>See Saw Noise Test</u>:

Agreement with Owner – residents have phone number of DJ.

4. <u>Good Neighbor Agreements</u>

- a. Agreements between the bars/restaurants and the neighborhoods.
- b. First meeting on December 02, 2021. (Separate working group)
- c. Bobby any comments ideas on good neighbor agreement
 - Making sure outside music shut off at a certain hour
 - Garage doors closed at a certain hour to minimize noise

Important to have the bar owners involved in these discussions
