### A. Meeting Logistics Updates – Bobby Thaxton

Meeting attendees discussed changing future meeting times for the SNCA to the 1<sup>st</sup> Thursday of the month at 6:30pm starting in October. This timing better align with upcoming VVC meetings.

Additional discussion was had whether to continue with the online option or to go back to in person. Different options were discussed. Some members felt this made the meetings more accessible and would encourage greater attendance. Others felt the logistics of coordinating the online participation was challenging to manage, had not proven to necessarily increase meeting attendance/engagement, and there were possibly other ways to boost meeting attendance while returning to in person only meetings.

- The parking czar has left the city and Amanda Ford has stepping into the role
- Evening parking exceeds pre-Covid levels
- Daytime parking lags pre-Covid primarily due to WFH and fewer events at the Convention Center
- Improvements continue to be made to the parking app to improve consistency of use
- The city is discussing whether they may want to move towards using a single vendor for scooters
