## IV. <u>City/Community Reports</u>

### A. City of Columbus Department of Development Presentation – Erin Prosser

- Erin is the Assistant Director of Housing Strategies in the Department of Development with the City of Columbus, a role she has filled since June of 2021. Prior to her current position, she served as the Director of Community Development in the Department of Planning, Architecture, and Real Estate at The Ohio State University, where she oversaw the addition of nearly 500 affordable housing units in Weinland Park area and the redevelopment of the 15th Avenue and High Street intersection.
- Erin presented an update on Columbus Housing Strategy, the Affordable Housing Bond, updated Residential Tax Abatement Policy, and the expansion of the AC Humko CRA.
- Affordable housing –goal to have housing that is safe and stable, close to transportation and amenities, suitable for needs of the family
- Keeping constant with housing production will be underwater by 2030 .98%
- Focus on 3 areas regarding housing shortage strategy
  - o Preserve
  - Invest, and
    - \$200m bond package for 2022
      - \$80M to support projects for individuals in the 30-80% median income
      - \$50M will be focused on affordable homeownership (permanent affordable homeowner opportunities through land trust model)
      - \$30M to support lower 30%
      - Remainder will go toward preservation
  - Include need for diversity
- Residential tax abatement study was completed to show value; policy updates approved in 2022 that requires 3 year review of program (handout provided that include comparison of policies in 2018 and 2022)

- 5 L's of Construction Laws, Land, Lending, Lumber & Labor
- Affordable housing tools
  - 1) Tax abatements
  - 2) Preservation
  - 3) Land trusts
- City of Columbus about to start a comprehensive rewrite of zoning
  Zoning code needs to allow for diversity and gentle density
- Erin will email materials
