- A. Approximately \$81,610 total

- IV. City Initiatives in Cycling Brian Ashworth, Transportation Planning Manager, Division of Mobility & Parking, Columbus Dep't of Public Service
  - A. The City has kicked off its Bike Plus + initiative
    - 1. The goals are to support a safe, connected, and comfortable network.
    - 2. The initiative is for everyone. It aims to accommodate the interested but concerned riding type, kids, and communities of interest as identified in the VisionZero plan.
    - 3. The last plan was adopted in 2008. A new plan is being created with substantial local input. The plan will be implementable rather than just aspirational.
    - 4. Cycling is being supported through projects (think construction) and programs (such as the e-bike incentive program).
  - B. Public engagement efforts are ongoing both online and in person.
    - 1. <u>A survey</u> is going from September 1 to October 31.
      - a) They have 2800 responses so far.
      - b) 85% of responses have been from white citizens, which as a demographic

comprises 58% of the city population.

- c) The City is aiming to gather twice as many responses and engage populations that are underrepresented.
- d) Themes so far include: better infrastructure, culture change, and environment and sustainability.
- 2. The City is planning more engagement opportunities coming over the next 10 months.
- C. They are trying to create a near term connected network (5 years).
- D. The City contracted with Toole engineering who will be doing the network assessment. This assessment will determine metrics for success (how close to grocery stores, parks, etc.)

## V. City Reports

- A. CPD Community Liaison Officer Mark Hauenstein
  - 1. A citizen was concerned about wrong way driving on Warren St.
    - a) SNCA members from Italian Village reaffirmed it as an issue and noted signage in certain locations may prevent some wrong-way driving.

- E. Jack announced that the Board has approved reimbursements of \$415.91 and \$341.00 for the repair of and winterization of the traffic median island irrigation systems along Neil

Ave.

- F. The Short North Violence & Injury Prevention Work Group met again. The towing focus along High Street will be revised to Second Ave through Fifth Ave on the west side of the street from 12AM to 4 AM.
- G. There is a new <u>Tree Code</u> and <u>Tree Manual</u>.

# VIII. Committee Reports

- A. Development Jack Decker
  - 1. The 335 W 3<sup>rd</sup> Ave project has made changes to address the concerns of the VVC. Seasonal infrastructure is still being discussed.
  - 2. A presentation on the VVC is forthcoming.
- B. Tour of Homes Caroline Stinziano
  - 1. The tour was very successful with over 1000 attendees. It generated  $\sim$  \$22,000 \$23,000 in income and 13 new memberships!
- C. Traffic Calming & Infrastructure Jack Decker
  - 1. The SNCA coalition initiative to slow down traffic in the Short North is ongoing.
  - 2. Jack Decker and Pete Anderson will meet with Dennison Place and the University Area Commission to expand the coalition.
