  - 1. City council taking action to support the creation of housing, digital equity through high speed internet, minority businesses, lead safe program, and a domestic violence hotline.
- B. CPD Community Liaison Officer Mark Hauenstein
  - 1. Community outreach events in high gear for the holiday season.
  - 2. Homelessness issues occurring along the river bank in Harrison Park. Liaisons are working to connect people with housing solutions, warming centers, and necessary medications. They are giving people time to make adjustments before the City disbands the camp and cleans up the river bank.
  - 3. A crime pattern has emerged with a female in a medical mask robbing or attempting to rob bank robberies.
  - 4. A group of juveniles stole a car in the area. The car was retrieved and firearms were found inside.
  - 5. Several car break-ins occurred in the area. Photos and video were captured of several young male teens performing these acts. A stolen car was retrieved. One of the individuals was apprehended and charged. A reminder was given to remove valuables from your car.
